#### **THE LIES: (from his book)**

Ted Cruz said his mother Eleanor's first son Michael Wilson was born (and later died) in 1965 while she was married to her first husband Alan Wilson.

"In 1960, they moved to London, and five years later my mom gave birth to a son, named Michael. For my mother, 1965 was a year of celebration and tragedy. My mom loved Michael and rejoiced in motherhood, but that December she awoke one cold morning to find that he had died in his sleep. Losing Michael to crib death broke my mother's heart, and had a profound effect on her, so much so that I never even knew that I had had a brother until I was a teenager, when my mom finally told me the story."

Ted Cruz said: "After meeting each other at Geocom in New Orleans, my parents had moved to Canada..."

In 1957, Rafael Cruz, the son of an employee of the U.S. intelligence-linked RCA Corporation, left Cuba for the United States. Cruz claims he fought with Castro against the fascist government of Fulgencio Batista but soured on the revolution.

#### **THE TRUTH:**

Michael Wilson was not the son of Alan Wilson—he and Eleanor divorced in 1963—and the baby was born out of wedlock in 1966. She gave up the baby for adoption and left the country - it died in a far-away country at the age of 5 months.

Eleanor moved from England to Canada in December, 1967

Cruz Sr. left Cuba two years before the Castro revolution. We know he was a friend of, and worked with LEE HARVEY OSWALD in 1962-1964 and the FLED to Canada, presumably to AVOID ARREST for his 'connection' to OSWALD (who was arrested for the SSASSINATION of President Kennedy). We still do not know everything we SHOULD know about Cruz Sr.

#### **THE REASON FOR THE LIES: (NOTE: Not much of Ted's Time-line in the book makes sense)**

Ted Cruz was born out of wedlock in 1970

#### **AND: Birth Abroad Out-of-Wedlock to a U.S. Citizen Mother:**

A person born abroad out-of-wedlock to a U.S. citizen mother may acquire U.S. citizenship under Section 309(c) of the INA if the mother was a U.S. citizen at the time of the person's birth and if the mother was physically present in the United States or one of its outlying possessions for a continuous period of one year prior to the person's birth. The U.S. citizen mother must be the genetic or the gestational mother and the legal parent of the child under local law at the time and place of the child's birth to transmit U.S. citizenship.

Hollrah, retired government relations executive and a two-time member of the U.S. Electoral College, explains that "According to the U.S. State Department, Bureau of Consular Affairs, the U.S. citizen parent(s) of a child born on foreign soil must obtain a Consular Report of Birth Abroad (CRBA, Form FS-240) at some time prior to the child's eighteenth birthday if the parent desires to pass on their U.S. citizenship to their offspring" and then wonders:

"So the question arises, did Ted Cruz's parents assemble all the necessary documents and then drive or fly to the office of the U.S. Consulate General in Montreal, a distance of 2,196 miles? Or did they simply rely on the fact that his mother was a U.S. citizen, assuming that her U.S. citizenship would be automatically passed on to her son?" All applicants will need to provide the following forms and documents:

"Parents of a child born abroad to a U.S. citizen or citizens should apply for a CRBA and/or a U.S. passport for the child as soon as possible.

Failure to promptly document a child who meets the statutory requirements for acquiring U.S. citizenship at birth may cause problems for the parents and the child when attempting to establish the child's U.S. citizenship and eligibility for the rights and benefits of U.S. citizenship, including entry into the United States. **By law, U.S. citizens, including dual nationals, must use a U.S. passport to enter and leave the United States.**"
